Takeaways

- As of 2023 the region's population **declined by 1.4%** since 2018, falling by 608. Population is expected to **decrease by 5.1%** between 2023 and 2028, losing 2,123.
- From 2018 to 2023, jobs declined by 0.6% in Pierce County, WI from 12,869 to 12,795. This change fell short of the national growth rate of 3.9% by 4.5%. As the number of jobs declined, the labor force participation rate decreased from 73.8% to 71.1% between 2018 and 2023.
- Concerning educational attainment, 21.2% of Pierce County, WI residents possess a Bachelor's Degree (the same as the national average), and 12.7% hold an Associate's Degree (3.8% above the national average).
- The top three industries in 2023 are Education and Hospitals (Local Government), Education and Hospitals (State Government), and Local Government, Excluding Education and Hospitals.




Feb 2024 Labor Force Breakdown






Unemployment by Gender



Unemployment by Ethnicity







Job Trends



Labor Force Participation Rate Trends




Pierce County, WI had a February 2024 unemployment rate of 4.47%, increasing from 3.22% 5 years before.




Millennials

Pierce County, WI has 2,036 veterans. The national average for an area this size is 2,224.




Retiring Soon

Racial diversity is low in Pierce County, WI. The national average for an area this size is 17,491 racially diverse people, while there are 3,006 here.




Property Crime






Top Growing Industries







Top Industry Employment Concentration






Top Industry GRP




Top Occupation Employment Concentration






